SLIDE: NO MORE NIGHTMARES, PT 1, CALEDONIA'S VICTIMS

Part 1: Caledonia's Victims (32:00)

SLIDE: CALEDONIA VICTIMS PROJECT LOGO

The image of the dancer in the Caledonia Victims Project logo is a tribute to a 14 year old girl named Pam Dudych who loved to dance – before her world turned upside down. [1-2]

SLIDE: DANCER AT LIONS PARK, OCT 08/07

Pam lives on the Sixth Line in Caledonia. The OPP withdrew policing service from her street on April 20, 2006 after hundreds of native occupiers attacked them while they were trying to enforce a court order.

Police were injured after being attacked with clubs, crowbars, axes, a chainsaw and socks filled with rocks. [1-3]

The court order was supposed to end an illegal occupation of a new subdivision across the street from Pam's house known as the Douglas Creek Estates which began on February 28th, 2006. Lawlessness escalated over time as it became clear to the occupiers they were immune from the law.

SLIDE: KWINTER LETTER RE NO CDN FORCES

The worst of the violence occurred after May 03, 2006 when the former Minister of Community Safety and Correctional Services acceded to the militant's demands not to call in the Canadian Forces to protect Caledonia. [1-4]

SLIDE: SAM GUALTIERI

So far native protesters have burned down a bridge and threatened to kill firefighters; attacked an elderly couple in their car; attacked journalists; assaulted and threatened residents, police and one another; destroyed the area's hydro station; thrown a vehicle over a bridge; blocked the town's main roads and rail lines; attempted to murder a police officer; polluted the environment with tire and grass fires; extorted money from non-native land owners; and left a builder with permanent brain damage after beating him nearly to death in the home he was building for his daughter. In 2007 CBC produced a documentary based on the 1,000+ hours of audio recordings of radio transmissions in our possession proving that occupiers had authorized the shooting of civilians and police, among other depravities. It was pulled shortly before airing, and CBC still refuses to air it. [1-6]

SLIDE: 'ROAD OF HOPE' PAMPHELET

We first met Pam Dudych and her family in March 2007. She had produced a heartbreaking pamphlet for a school project called, *Road of Hope: Help the Sixth Line!* and wanted the world to hear her words of pain, so we took her to Queen's Park to share her story at a news conference [1-7]:

SLIDE: DEER CARCASSES ON POLE

Pam's mother showed me the pass natives forced them to carry, as well as a photo of two of the seven deer carcasses hung by occupiers on a lamp pole near their home between October and December 2006 where kids on the school bus could see them.

Her diary entry for October 30th at 3:50 pm notes this about the 5th carcass: "Between yesterday at 1:30 and now, the deer was taken down, skinned and beheaded and then hung back up. Mayor called." Her mom wrote me saying, "See[ing] the deer each time gave you a sickening feeling in your gut."

SLIDE: VAN PUSHED OVER BRIDGE, FIRE BELOW

Another Caledonia resident asked me to share one of his experiences:

“The police and firemen were hiding behind my fence while a group of natives (terrorists)!! were lighting a fire behind my house. They said to my neighbour and myself we cannot protect you or touch them. [...] We were and are still treated as shit by the police. My trust in our system is gone forever.” [1-9]

OPP testimony at the trial for the Brown-Chatwell lawsuit which was heard - and later cited - by Christie Blatchford in Helpless confirms that the Haldimand commander was ordered *not* to arrest rioting natives whom he said were emboldened by the lack of police response. [1-10]

SLIDE: TIRE FIRE

Residents were forced to stand guard one night at the home of a 92 year old World War Two veteran named Jack Dancy because OPP officers refused to stop native occupiers from throwing rocks at his house. This war hero later showed me one of the rocks and tearfully told me, “I spent 5 years in hell for this country and now I don’t even know if the police will protect me. It wasn’t worth it.” [1-11]

SLIDE: YOUTHS W/CLUBS, MASKS

In 2010 Pam’s mother shared her feelings about the return of the OPP to the Sixth Line -- four years after they were abandoned by their police:

We have lost 4 years of our lives which we will never get back. [...] I feel like Canada has let us down big time. For a land that is supposed to be free, we are prisoners of war who have been left to deal with this predicament on our own. [...]As for policing back down here, yes it’s true. Do we feel any safer - NO.

SLIDE: NAZI SYMBOL ON JIM SMITH HOME

False accusations of being white supremacists are common against non-native victims and activists – including for this event. Intimidation has also included physical assaults, and death and torture threats.

SLIDE: CALEDONIA CITIZENS ARE RACISTS CARTOON

“Are you white? Are you a complete failure? Do you want to avoid responsibility for your failure? Then...CITIZENS OF CALEDONIA... Become a White Supremacist!” The guy on the left says “I’m a bigot. I hate Indians. The guy with the swastika on his chest says, “Duh! My mama is white! Caledonia is white!”

SLIDE: DCE SIGN – BOYCOTT RACISM, KEN HEWITT, MAYOR, CLARKE

SLIDE: DCE SIGN – KEVIN CLARKE COWARD OF THE COUNTY

SLIDE: DCE SIGN – KKK PLUNDER

SLIDE: JEFF PARKINSON IN HOSPITAL, GARY MCHALE IN HOSPITAL

SLIDE: FANTINO SHARES JOKE W/POWLESS

After Gary McHale was sent to hospital in December 2007 the former OPP commissioner was photographed sharing a joke with the native man who led the attack, but he refused Mayor Trainer’s September 2009 request to meet with Sixth Line residents, which would have included Pam Dudych’s family. **[1-12, 13]**

SLIDE: ARRESTS OF BO CHAUSSE, RANDY FLEMING, GARY MCHALE, MARK VANDERMAAS

Four non-natives have been arrested for trying to raise a Canadian flag near the occupation site. **[1-14]** A Caledonia resident - a police officer - who criticized Ontario’s Premier faced a Police Services Act charge after a government negotiator complained to the OPP who in turn filed a complaint with the Hamilton Police Service. It was held to be unfounded. **[1-15]**

In Mr. McHale’s case the OPP repeatedly targeted him for defamation and false arrests, a campaign that resulted in charges of Obstructing Justice against the now-present commissioner and a superintendent, and a charge of Influencing Municipal Official against the former commissioner. **[1-16]**

OPP officers have even visited hall owners to intimidate them into cancelling room rental agreements so we could not speak. **[1-17]**

SLIDE: CAUGHT IN THE MIDDLE

It is difficult to convey to you the absolute terror, hopelessness, trauma and sense of betrayal the people of Caledonia feel to this day. Perhaps it is enough to tell you that Pam Dudych must take medication and go to counselling; Pam's mother takes medication for her diagnosis of post traumatic stress disorder and has attempted suicide; Pam's father has had a heart attack; the family business is in ruins, and they cannot leave because they cannot sell their home. **[1-18]**

SLIDE: KKK SIGN MONTAGE W/SAM GUALTIERI, BRIDGE FIRE

This sign is from the Stirling Street subdivision where native occupiers burned down the bridge, and left Sam Gualtieri with brain damage from their vicious beating. **[1-19]**

The words 'heartless' and 'cruel' seem inadequate to describe the irony of a situation wherein an organized group from one race of people terrorized others with racial slurs, fire, violence, vandalism, and property seizures and then tormented their victims with false accusations of being white supremacists.

As the son of parents who lived in Nazi-occupied Holland I am offended to the very core of my being by the blaming of innocent victims for racially-motivated crimes committed against them.

SLIDE: MERLYN W/SIGN - 'TWO TIER JUSTICE VICTIMIZES NATIVE PEOPLE TOO'

I am also offended that Six Nations people have been unintended victims of the same racist policing policies that allow illegal occupations to escalate and the sites to become lawless 'home-free zones' – as residents in both Caledonia and Ipperwash refer to them. Occupation sites have seen rapes, assaults, arson, drug use and gun violence. **[1-20]**

A Six Nations paper confirmed that the shooter of a Six Nations man at a nearby smokeshack had been on the occupation site near the homes of residents threatening another man over a drug debt with an AK47 assault rifle just prior to the shooting.

In August 2007 another Six Nations paper cited former Six Nations Chief David General's opinion that "he does not consider [the occupation site] sacred land, citing two reported rapes and several other unseemly acts which have been reported from the reclamation site."

In both Ipperwash and Caledonia – ironically – original occupiers have expressed fear over the lawlessness that developed in the aftermath of their own lawless takeovers.

So where do we go from here?

[SLIDE: RECONCILIATION: THE CANACE PATH]

This drawing, which we first presented in September 2008 to Brantford Council, and later to the OPP, is called '*Reconciliation: the CANACE Path*'. We must commit to a path of truth, justice, and apologies: from Six Nations; the OPP and the Ontario government. There are *no* shortcuts, *no* alternatives. If the government of Canada can – rightly - apologize for Residential Schools then these groups can apologize for Caledonia [1-21].

Unfortunately, five months after the release of *Helpless*, the present OPP commissioner has not read the book nor has the Haldimand commander. [1-22]

As we finally begin to talk about victims and solutions we must also acknowledge that those who terrorized Caledonia do *not* represent the good people of Six Nations or aboriginal people in general.

SLIDE: NO MORE NIGHTMARES, PART 2, CALEDONIA MYTHS & POLICY ISSUES

Part 2: Caledonia Myths & Policy Issues

Now that we've discussed Caledonia's victims let's examine some of the key myths and policy issues that need to be exposed and addressed.

SLIDE: VEXATIOUS LAND CLAIMS

Vexatious land claims. The Six Nations people are *not* indigenous to Canada, they lived in the area south of the Great Lakes in what is now the United States. When they were dispossessed of their lands after the American Revolutionary War the Crown rewarded them for their service as loyal allies by purchasing the Haldimand Tract from the Mississauga Indians as a refuge for them as per the Haldimand Proclamation of 1784. [2-1]

SLIDE: HALDIMAND TRACT MAP

The Six Nations people were treated honourably by a grateful Crown. Canada did *not* steal land from them; it bought it for them so they could settle here in safety. Six Nations later surrendered large portions of the tract for sale.

The federal government has stated that these surrenders were valid and it does not recognize the Douglas Creek Estates in Caledonia as a valid claim. [2-2]

According to three different Superior Court judges who have ruled against three other illegal occupations in Cayuga, Hagersville and Brantford, the recognized representatives of Six Nations have not made any claim for possession or return of the Haldimand Tract, and such a claim would not succeed even if they did. The only claims Six Nations *have* made is for monetary compensation that may be owing. [2-3,4]

In 2010 a Superior Court judge granted Brantford an injunction against violent occupations that were destroying the city's economy. After reviewing a report on the Haldimand Tract land transfers by an expert from the Ipperwash Inquiry and the related documents he ruled as follows:

“For more than 150 years the Six Nations did nothing to indicate to innocent third-party purchasers that there was any problem with title to their lands. Property has been bought and sold over that time period. The Six Nations did commence a claim in 1995 against the federal and provincial governments seeking compensation but never for return of the land. Still there was no notice to private landowners, when that action was commenced or after, of any problem with their title. [...] It was not until this case commenced that the Six Nations claimed to have the right to control the activities of private landowners on the basis that the private land within the City of

Brantford belonged to the Six Nations. I conclude such an argument must fail.” [2-5]

Despite the vacuous nature of their claims native lawbreakers were able to create a cascade of benefits for themselves. In a letter dated April 17, 2006 the provincial and federal governments attempted to bribe the occupiers to end their occupation with offers that included the transfer of 380 acres of land from a former correctional facility (which was done); the possibility of even more land transfers; “research funding for land and resource issues”; and funds for “public education regarding land claims...” [2-6]

In September 2008 the Turtle Island News reported details of an audit showing that in one year Six Nations received \$1,131,382.00 for negotiations, some of which was paid to members of the Haudenosaunee Development Institute (HDI) and the Haudenosaunee Men’s Fire (HMF) who were involved in illegal occupations and intimidating non-native landowners. [2-7]

Between 2006 and 2007 Brian Jesse Porter, who would eventually be charged for pulling a stolen hydro tower across Caledonia’s main road on December 1, 2007, received \$131,240 as stated by Ontario’s Ministry of Finance in its Public Accounts of Ontario report. [2-8]

[SLIDE: CALEDONIA: A NATIONAL SECURITY ISSUE]

Caledonia is a national security issue. What has never been admitted publicly by the OPP or Ontario government is that native criminals are being aided by a coalition of anarchists, radical unionists, and anti-Israel groups led by an anarchist named Tom Keefer from Local 3903 of the Canadian Union of Public Employees at York University. [2-9]

SLIDE: TOM KEEFER

Tom Keefer and CUPE 3903 - with help from other locals from CUPE; CAW; OPSEU; CEP and USW - began supporting aboriginal militants in Caledonia after the failed OPP raid of April 20/06 when police were driven off the occupation site after being attacked with weapons. [2-10]

By this time, according to OPP testimony at the Brown-Chatwell trial, the Caledonia occupation site was taken over by the Mohawk Warriors which police considered to be “akin to the Hell’s Angels” -- a group which was involved in organized crime, cigarette running, with a reputation for physical confrontation and access to guns, including assault rifles. [2-11]

SLIDE: MOHAWK WARRIORS TAKE CHARGE OF CALEDONIA LAWLESSNESS

The Warriors murdered Quebec Police Corporal Marcel Lemay in Oka and they were in Ipperwash during the violent takeover of the Canadian Forces base there which led to the death of Dudley George and further intimidation of residents. [2-12, 13]

In addition to supporting the Warriors, Keefer states in a Nov 15, 2009 report his coalition is “working closely” with the Haudenosaunee Men’s Fire (HMF)[2-14]. On April 03, 2009 the Superior Court judge ruling against the HMF illegal occupation in Hagersville said they had engaged in “Extortion, Intimidation, Nuisance, Trespass and Inducing Breach of Contract.” [2-15]

Members of CUPE 3903 were “present on the barricades” when Six Nations militants blockaded the major Highway 6 by-pass around Caledonia for 4 days in April 2008, and contributed financially to this illegal action. [2-16]

Keefer & CUPE work with the Anarchist Black Cross Federation and the Freedonia anarchist foundation. [2-17]

In his report Keefer states Freedonia donated \$3,000 to CUPE, \$1,000 of which was funnelled to Jim Windle, a reporter with Tekawennake News on Six Nations who published articles trying to smear us as white supremacists [18]. After we filed a lawsuit, the Teka’s publisher printed a ‘clarification’ saying it had *no* evidence we were associated with such groups. [2-19]

SLIDE: FREE PALESTINE/PALESTINA LIBRE

Freedonia also gave money to an anti-capitalist newsletter in Toronto called BASICS. Editor Steve da Silva was an invited speaker at a Keefer/CUPE June 23, 2009 anti-Caledonia protest in Cayuga. [2-20]

BASICS' MySpace page provides a list of its "heroes" which include: Mao Tse-tung; Marx; Lenin; Che Guevara; Fidel Castro; Malcom X; and the Black Panther Party. 'Friends' of BASICS include 'Free Palestine' which uses a logo showing Che Guevera under the slogan "Palestina LIBRE."

[2-21]

[SLIDE: PALESTINIAN FLAG W/WARRIOR FLAG ON DCE]

This is a picture of the Palestinian flag flying on the occupied Douglas Creek Estates along with both the Six Nations and Mohawk Warriors flag. It was placed there by the Niagara Palestinian Association on May 03, 2006.

[2-22]

[SLIDE: CAF VP ALI MALLAH WALKS BESIDE WARRIOR FLAG & PORTRAIT OF HEZBOLLAH LEADER]

This is the Vice President of the Canadian Arab Federation Ali Mallah in a 2006 protest walking beside someone carrying a Mohawk Warrior flag and another carrying the portrait of Hasran Nazrullah, leader of the terror group Hezbollah [2-23]. On November 27, 2006 the Canadian Arab Federation petitioned the Canadian government to have both Hezbollah and Hamas removed from the list of terror organizations. [2-24]

SLIDE: CAF VP ALI MALLAH SPEAKING NEAR WARRIOR FLAG

Another picture of Ali Mallah speaking beside the Mohawk Warrior flag. [2-25]

SLIDE: SPEAKER, WARRIOR FLAG, ANTI-ISRAEL POSTER

This picture shows the Warrior flag with an anti-Israel poster depicting the Israel Defence Forces as heartless murderers intentionally dropping a bomb on a child, and a Jew as a hooded executioner. [2-26]

Another group active in supporting lawlessness in Caledonia is the Christian Peacemaker Teams. The UN has condemned the Hamas charter for laying out a "blueprint for jihadist terrorism" directed at killing Jews and destroying the State of Israel, but the CPT's FAQ page for their Palestine mission portrays Hamas as a humanitarian organization. [2-27]

SLIDE: TAMIL TIGER T-SHIRT AT CUPE 3903 PROTEST

At the June 2009 anti-Caledonia protest one of Keefer's speakers expressed his solidarity with those wearing logos of the Tamil Tigers terror group.

[2-28]

SLIDE: DCE, JAN 20/07, TORONTO CUPE EDUCATION WORKERS, 1005 STEELWORKERS, MOHAWK WARRIORS TOGETHER

In a paper entitled *Declaring the Exception: Direct Action, Six Nations, and the Struggle in Brantford* Tom Keefer laid out a plan showing how economic warfare against Brantford could force the government to grant native militants an area not subject to Canadian law:

"A second way for Six Nations to win is if they can escalate their blockades in a manner that continues to financially hurt the City of Brantford while also making clear that attempts at police or military intervention would be costly and impractical means of resolving the situation. By escalating direct action tactics and mobilizing a larger number of people from Six Nations, this approach might force the City of Brantford to recognize Six Nations land rights and sovereignty through some kind of wide ranging and innovative agreement with the Confederacy and the HDI. **[2-29]**

According to MPP Toby Barrett communities within the Haldimand Tract have suffered an estimated \$4.1 billion – with a ‘B’ – dollars in economic losses due to native lawlessness. **[2-30]**

Six Nations Councillor Helen Miller, in a letter written to the Brantford Expositor July 14, 2009, the people of Six Nations are “fed up with the protests, [and] fed up with these groups of people and individuals claiming to speak for them.” She goes on to say, “As for who represents Six Nations let me put it this way: The Mohawk Workers, Women of the Mohawk Nation, the Men’s Fire or individuals like Steven “Boots” Powless or Ruby and Floyd Montour were not elected, appointed or authorized by the people of Six Nations to be their representatives or to speak on their behalf. Nor is the Haudenosaunee Development Institute (HDI) supported by the elected council or the community at large.” **[2-31]**

Nevertheless, Keefer and CUPE continue to bring non-native radicals into Caledonia to support these groups. Despite being forewarned they were bussing in people to disrupt our February 27th Truth and Reconciliation rally, the OPP refused to provide officers to separate them from us; refused to prevent them from trespassing on the private property we were forced to relocate to; and watched as we were screamed at, assaulted, and set up for bogus assault charges. One of the two shocked observers from the International Free Press Society present that day said, “I didn’t feel as though I was in Canada.” [2-32]

SLIDE: CANADIAN FLAG UPSIDE DOWN W/LOCAL 1005 BANNER

Make no mistake about it: Caledonia is the front line for extreme left wing radicals who are using native crime groups as proxies for their own anti-capitalist, anarchist mission to undermine the rule of law in Canada.

SLIDE: ILLEGAL PEACEKEEPING MISSION ON CANADIAN SOIL

Now let’s talk about Ontario’s illegal peacekeeping mission on Canadian soil. The Ipperwash Inquiry includes four recommendations which suggest the OPP, other police forces and the Minister of Community Safety & Correctional Services enact so-called ‘peacekeeping’ policing policies during aboriginal disputes. [2-33]

Both the Premier of Ontario and the former Commissioner of the OPP have referred to the OPP role in Caledonia as being that of ‘peacekeepers.’ On May 02, 2007 the Premier actually joked on TV about having to issue blue helmets to the OPP.’ [2-34, 35]

SLIDES: UN PHOTOS 1-10 (SELF-RUNNING)

The obscenity of this joke is underscored when one reviews a list of countries where UN peacekeepers are currently deployed: Liberia; Ivory Coast; Haiti; Sudan; Lebanon; East Timor; Darfur; Kosovo; Chad; and the Congo. [2-36]

The UN says this about the role of peacekeeping in restoring the Rule of Law in failed states:

Rule of Law is the legal and political framework under which all persons and institutions, including the State itself, are accountable. Establishing respect for the rule of law is fundamental to achieving a durable peace in the aftermath of conflict.

Laws need to be publicly promulgated, equally enforced and independently adjudicated and be consistent with international human rights norms and standards. Peacekeeping works to strengthen police, justice and corrections institutions, as well as the institutions that can hold them accountable.

Since 1999, all major peacekeeping operations, and many special political missions, have had provisions to work with the host country to strengthen the rule of law. [2-37]

Obviously, then, peacekeeping missions are *not* deployed to undermine the rule of law in stable democracies by withholding law enforcement protection from innocent civilians to appease armed aggressors of a favoured race.

Strangely, not one politician or journalist has ever thought to ask some seemingly-obvious questions:

1. Who has the authority to authorize a peacekeeping mission on Canadian soil?
2. What legal authority exists for substituting a peacekeeping policy in place of the legal protections of the Charter of Rights and Ontario's Police Services Act during any land claim, let alone an imaginary one?
3. If Canadian citizens in Caledonia have so much in common with those in failed states such as Haiti, Darfur, Kosovo and Liberia that they require a peacekeeping mission, why have our federal and provincial governments turned blind eyes to their plight?

SLIDE: HOW THE IPPERWASH INQUIRY FAILED CALEDONIA & CANADA

Now, let's take a brief look at the dangerously-flawed process used by the Ipperwash Inquiry to arrive at its peacekeeping recommendations. It is commonly believed that the Ipperwash Inquiry studied how to prevent violence during land claims, a reasonable assumption given it was sitting during the height of the violence in Caledonia. Unfortunately, it did not.

[SLIDE: IPPERWASH INQUIRY COVER]

The inquiry only examined how to prevent police violence against native protesters; it *did not* allow the issue of native violence against innocent Ipperwash residents to be studied even though they were victims of a vexatious land claim against their homes filed in 1992 which marked the beginning of a reign of terror similar to that waged against Caledonia. [2-38, 39]

Despite their nightmare, out of 139 witnesses at the Ipperwash Inquiry not one resident was allowed to testify. The evidence of their suffering went un-entered into the record and...un-noticed by the media.

During the three years the inquiry was in session non-natives were granted a mere 90 minutes with the Commissioner which took place at a single townhall meeting on June 21, 2006 at the height of the violence in Caledonia – and the minutes of that meeting were sanitized.

This is why, out of 100 recommendations *not one* is specifically directed at the prevention of native violence against innocent residents. [2-40]

SLIDE: ‘CRIMES AGAINST DEMOCRACY’

To conclude: the Ontario government knows full well the Ipperwash Inquiry did not allow the vital issue of native violence against residents to be studied yet, it continues to use its skewed recommendations to justify the wholesale subversion of the protection non-natives are entitled to under the Police Services Act and the Charter of Rights and...it continues to allow criminals, anarchists, and the OPP to victimize them – all under cover of phony land claims and an illegal peacekeeping mission. In my opinion Caledonia represents an ongoing crime against democracy that must be ended, and ended NOW.

“Lewis says he has not read Blatchford’s book, which was highly critical of OPP actions during the early days of the reclamation of DCE, and would not comment on it directly, but he spoke in generalities about it and the effect its release and the antics of McHale continues to have on the situation, on the ground.

“Lewis acknowledged that incidents he has heard portrayed in the Blatchford book, point primarily to 2006 and early 2007, the first year of the conflict when the situation was much more serious than [sic] in more recent years. “The only incidents that did happen (over the past three years or more), came as a result of some outside influence,” he said. “It wasn’t generally the people of Caledonia, nor was it the people who were living at the DCE – or occupying it to use that word. Rather they were outside influences who came in to try and cause some sort of argument or whatever, allegedly to make a point. But let’s face it. The point they were trying to make, in my view, was to cause some sort of reaction and we can’t allow that sort of thing to happen and place women, and children or whoever, in jeopardy, including our officers.”

NOTE: The current Haldimand Detachment commander confirmed in an email to Gary McHale that he had not read Helpless and would not accept a copy from him to read.

“Contributing to this extensive deployment was the Mohawk’s own fortifications. At the time of the July 11 S.Q. raid, the Mohawks had approximately 75 men armed with shotguns, high powered and semi-automatic pistols, a magnum revolver, assault and semi-automatic AK-47 rifles, a fully automatic machine gun, and several thousand rounds of ammunition. Over time, the Mohawk Warriors made more contributions to their arsenal, including a semi-automatic machine gun capable of firing 450-600 rounds per minute and of penetrating an APC. After a preliminary assessment of Mohawk fortifications and arms, the Army concluded that the Mohawks were “a highly organized paramilitary force.”

“Although newspapers reported that Mohawks had as many as 6000 guns, the more plausible figure of 500-600 was reported by Geoffrey York’s text. Guns and ammunition continued to be smuggled in during the crisis, with a shipment of 80 AK-47s arriving in Kahnawake on the third or fourth week of the standoff. A number of decoys were also set, leading to television reports, for example, of a M72 rocket launcher. Similarly, it was never determined whether the wiring located on Mercier Bridge was actually an explosive or a hoax. A number of tank traps were set to halt APCs progress, and the bush in the Pines around Highway 138 was littered with lethal traps, resembling those the Vietnam veteran Warriors had perfected in that war. At its peak, as many as 500-600 Mohawks armed the fourteen bunkers and barricades surrounding the disputed territory.”

Hi, I'm from Basics Free Community Newsletter. We're a people's newspaper in Toronto. A lot of the points have already been touched on here today but I just wanted to touch on one more thing that I, kind of a contradiction that I don't think has been brought out so far. [...]

And it's really sad that in the situation today - right? – this part of Ontario, this part of Canada, one of the most rapidly de-industrializing parts of the country where the white working class is being thrown onto unemployment in record numbers that we have facism rising, and facism is an appeal to the white working class in order to turn against the rest of the working class while all of us are getting fucked – right? - while our enemies, the ruling class, the police – right? - and the army that protects them are going to divide and they're going to conquer us.

While you're arming yourselves to go to war with your brothers and sisters, the rest of the working class, the indigenous people, the original title holders to this land. That's the contradiction [UNINTELLIGIBLE]. If we don't understand that contradiction we will be divided. We will be defeated. Canada will continue to be a parasite nation. Canada will

continue with its imperialism. And it will continue to defeat us, but united, together, we will defeat the system.

“One of the proudest moments in the lives of McMaster SPHR [Solidarity for Palestinian Human Rights] and my life and the Palestinian Solidarity Movement was the day that the Palestinian flag was raised over the reclamation site. That day the Niagara Palestinian Association along with the Haudenosaunee people, hoisted and raised the Palestinian flag alongside the flags of the Haudenosaunee, of various other countries, of unions and many organizations. In the months following, through cold and moments of exhaustion and worry we would raise our eyes to the swaying of the flags and think, we are one, and the winds carry our colours together from Jerusalem to the Grand River.”

SPHR members were on the DCE occupation site shortly after the occupation began:

EXCERPT 2

“SPHR [Solidarity for Palestinian Human Rights] members, two weeks after the sacred fire was first built, went as a delegation with other members of the Palestinian Solidarity Movement from Toronto to join that sacred fire, that simple stand.”

But, we're here...one of the things we all should be talking about is solidarity. Solidarity amongst not only First Nations people but solidarity with every oppressed people all across the planet. We have...what I'm talking about...I see a couple of people here, over here, with **Tamil Tigers T-shirt** over there..."
